Beto for Texas is a Texas specific-purpose committee. Gwendolyn Pulido is the treasurer of Beto for Texas. Under Texas law, Ms. Pulido is responsible for filing campaign finance reports and maintaining records of reportable activity of Beto for Texas (see Election Code secs. 254.001, 254.123, and 254.124).

On information and belief, Ms. Pulido violated Election Code Secs. 254.031(a)(1), (3), and (6). These provisions generally require political committees to report all their political contributions and political expenditures made during a reporting period.

On the January 18, 2022 Beto for Texas campaign finance report, covering the committee's activity through December 31, 2021, Beto for Texas reported total political contributions of \$8,951,637.80, total in-kind contributions of \$1,729,946.13, and total political expenditures of \$3,690,970.38 (of which \$3,676,032.56 were reported on Schedule F1 as political expenditures from political contributions). On information and belief, expenditures were over-reported by \$1,729,946.13, or political contributions were over-reported by \$1,729,946.13.

In the report, Ms. Pulido/Beto for Texas show in-kind political contributions (Schedule A2) from Powered by People as follows:

On the same report, Ms. Pulido/Beto for Texas shows political expenditures from political contributions (Schedule F1) to Powered by People as follows:

Ms. Pulido/Beto for Texas also show political expenditures from political contributions to End Citizens United (11/30/2021, \$368, "In-Kind: Text Messaging"), End Citizens United Non-Federal Texas (11/30/2021, \$2,042.11, "In-Kind: Online Ads"), Frank Herrera Jr. (11/16/2021, \$2,483.93, "Catering"), and Let America Vote (11/30/2021, \$352.00, "In-Kind: Text Messaging").

As defined, an in-kind contribution is "a contribution of goods, services, or any other thing of value that is not money, and includes an agreement made or other obligation incurred, whether legally enforceable or not, to make the contribution. The term does not include a direct campaign expenditure." (Election Code Sec. 251.001(21)). Thus, in-kind contributions are non-monetary contributions to a political committee, and are reported separately. Political expenditures, on the other hand, are expenditures made from the committee's funds. If a person gives a political committee something of value as an in-kind contribution, it does not constitute a political expenditure by the committee. Similarly, if a political committee makes a political expenditure from its funds, it does not constitute an in-kind contribution by the vendor paid.

On information and belief, based on the January 18, 2022 campaign finance report, Ms. Pulido/Beto for Texas reported each in-kind contribution as both an in-kind contribution from the donor (Schedule A2) and a political expenditure from political contributions (F1) to the donor. Alternatively, Ms. Pulido/Beto for Texas reported expenditures as both Schedule F1 expenditures to each payee and Schedule A2 contributions from each payee. In doing so, Ms. Pulido/Beto for Texas misreported either the total amount of political contributions (report page 2, box 2) or the total amount of political expenditures (report page 2, box 4), including the total amount of in-kind political contributions (report page 3, box 2) or the total amount of political expenditures from political contributions (report page 3, box 8).

Based on the above reasons, Ms. Pulido violated Election Code Sec. 254.031(a)(1), (3), and (6).

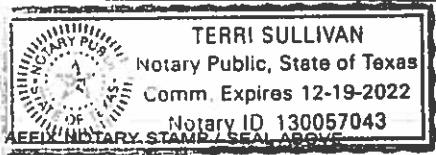
